Latest Information from the ESFA

- 1. There is <u>published guidance</u> from the ESFA for academies that are sending in their Financial Statements year-end submission.
- The arrangements for school funding for 2019-20 have been announced: <u>Teachers pay grant</u> will continue in academic year 2019 to 2020; Pupil premium will continue at the current per-pupil rates for the 2019 to 2020 financial year, you can <u>read the published pupil premium conditions of grant</u>; The grant for universal infant free school meals (UIFSM) continues at a meal rate of £2.30 for the 2019 to 2020 academic year; The year 7 catch-up premium continues in financial year 2019 to 2020; The <u>free school meals supplementary grant</u> will continue in 2019 to 2020; The grant for key stage 2 moderation and key stage 1 phonics will continue in financial year 2019 to 2020, and will be paid in August 2019; Education services grant (ESG) protection for academies will continue in the 2019 to 2020 academic year.

- 3. In the Budget, the Chancellor announced an extra £400 million capital funding for schools in 2018 to 2019. The ESFA has published a <u>ready reckoner</u> to help schools and other eligible institutions estimate the allocation they can expect to receive and so plan how to spend the money.
