Three Important Messages for Payroll Customers

1. As schools will continue to have varying staffing arrangements during July, our intention is to pay July salaries using the information that we have already received. Please, if you can, let us know of leavers or unpaid leave so that we can prevent any overpayments.

In the event of no information received, a flat month's pay will be processed for employees unless we are advised otherwise by means of an email instruction.

2. We would be grateful to know by the end of term, the schools that will be open during August and therefore staff will be available to check their pre-payroll reports in line with your payroll deadline schedule previously published.

If all schools could please email payroll@fs4s.co.uk with their response by the end of term it would be appreciated.

3. For any employees that may be leaving your school and currently receive their payslip to a work email address, you may wish to notify us of a personal email address when completing a leaver form, so their final payslip and P45 are sent to their personal email address.

Pensions Information

The Local Government Pension Funds would like employers to reassure employees that the LGPS is a defined benefit pension scheme which means your pension is based on your salary and how long you've paid in. Your pension is not linked to stock market performance, so both your contributions and your pension, whether in payment or not, will be unaffected.

The only exception to this is Additional Voluntary Contributions (AVCs). If you have an AVC, it is possible the value may have reduced - this will depend on the funds you have chosen to invest in. You should contact your AVC provider for more information about this.
